Direct deposit must be new to PPCU and a minimum of \$1,000 per month. Savings or Share Certificate balance must remain at least \$500 for two consecutive months to qualify for offer. Minimum opening deposits are \$5 for Savings, \$25 for Checking, and \$500 for Share Certificates. Savings accounts require an average daily balance of \$100 or more to earn 0.10% Annual Percentage Yield (APY). Rate is effective as of January 1, 2025. Amount of new personal or auto loan must be at least \$5,000 with no prepayments for 60 days. All loans are subject to credit approval. Former members qualify as new members six months after an account is closed. Bonuses will be posted to primary savings accounts within 30 days of all offer requirements being met. Membership qualifications apply. Referral Program is subject to change without prior notice.
